

## MATERIALS ACCEPTED

### MUNICIPAL SOLID WASTE

(Please, clear or white bags only.)

- Non-hazardous household waste.  
Includes: packaging, foils, plastic films, non-recyclable containers and lids, kitchen and bathroom trash, food scraps, disposable tableware and tissues, non-reusable clothing and accessories, disposable items, broken durable goods.

### RECYCLABLES

(Keep separated from other wastes)

- Please remove caps and rinse all bottles and cans
- Plastic bottles and jugs
- Glass bottles (clear, green, & brown)
- Metal food and beverage containers
- Corrugated cardboard (please flatten)
- Newspaper
- Magazines, mail, office & computer paper
- TV's and computer monitors are hazardous waste and must be separated.

### CONSTRUCTION & DEMOLITION DEBRIS

- Structural debris, wall coverings, plaster, drywall, plumbing, insulation, siding, shingles, pipe, sheeting, wiring, floorings, carpeting. **Volume limit of 55 gallons per day.**

## SPECIAL WASTES

---

- House/Apartment clean-outs are subject to all solid waste and recycling guidelines.
  - Please separate all materials!
- Litter clean-ups, illegal dumping, and litter in black bags will be investigated to identify the illegal dumper.
- Ovens, stoves, and appliances that do not contain freon or other refrigerant gas are accepted at the Solid Waste Management Center.
- Scrap metal should be delivered to the Solid Waste Management Center or scrap yard.
- Paint cans with residual paint must be dried out or filled with cat litter, and the lids removed prior to disposal with C&D. Empty and clean paint cans are recycled with scrap metal at the Solid Waste Management Center. Full paints should be brought to the CLEAN SWEEP. Contact Delaware County DPW for more information.

## TRANSFER STATION GUIDELINES

---

- Transfer station open to residents and land owners of the Town of Bovina.  
Users must first obtain a permit sticker from Town Clerk.
- Permit sticker should be clearly visible on rear view mirror of vehicle.
- Only wastes and recyclables generated within the Town of Bovina will be accepted for disposal.
- All solid waste deposited in plastic bags must be white or clear plastic bags.
- To prevent litter, NYS law requires all loads to be covered during transport.

## PROHIBITED ITEMS

---

JUNK VEHICLES, BODY, CHASSIS bring to a scrap dealer.

BATTERIES (vehicle & household)  
Bring to the Solid Waste Management Center for recycling.

BURN BARREL ASHES

DEAD ANIMALS AND CARCASSES

HAZARDOUS, TOXIC or FLAMMABLE MATERIALS - Includes fluorescent bulbs, mercury vapor lights, ballasts, transformers, pesticides, gasoline, and kerosene. Save for CLEAN SWEEP event in the fall.

TIRES – bring your tires to the Solid Waste Management Center for recycling. There is a limit of 8 tires per person and they must be off the rim.

LEAVES, YARD WASTE, GREEN OR LEAFY WOOD - Chip and/or compost at home.

LIQUIDS OF ANY KIND - Paints must be dried or mixed with cat litter. Save for CLEAN SWEEP event in the fall.

PROPANE TANKS - Return to a tank exchange at your local convenience store.

AIR CONDITIONERS, REFRIGERATORS, FREEZERS, DEHUMIDIFIERS - Bring to the Solid Waste Management Center for recycling.

USED MOTOR OIL & ANTIFREEZE - Bring to your local service station or the Solid Waste Management Center for recycling.

BULKY FURNATURE Bring to the Solid Waste Management Center for recycling.
